In continuation of our Technical and Price Bids submitted for the subject captioned above, we are to quote our rates as under :

**Offered rate for Composite Transportation (including Ancillary Services) of Bagged Fertiliser from any permissible rake point or from any warehouse/godown located in \_\_\_\_\_ District / Rake point to ANYWHERE in West Bengal State.**

NOTE: A) The rate for local movement is to be quoted directly per MT basis for distance up to 10 km irrespective of distance. For example:-

If the rate quoted is Rs.40/- per MT for local movement and if distance is either 2 km or 5 km or 7 km or 9 km or 10 km, the rate is Rs.40 per MT.

B) The rates are to be quoted on the flat slab basis. The rates quoted against each slab will be directly applied to calculate the payable amounts. For example:-

If the rate quoted is Rs.1.50 per MT per km. for the slab of 11 to 25 kms. And Rs.1.25 per MT for the next slab of 26 to 50 kms, the goods moved to a distance of 40 kms as it falls in the slab of 26 to 50 kms., the rate of Rs.1.25 per MT per km. will be applicable.

For distance of 40 kms -  $40 \times 1.25 = \text{Rs.}50.00$  per MT
